

# CEASE AND DESIST ORDER

Notice to Agent is Notice to Principal; Notice to Principal is Notice to all Agents

We, the living men and women of, New Zealand, bring to your immediate attention and order you to cease and desist, all support for or enabling of the Genocide and Crimes against Humanity under Natural Law, Common Law, Treaty Law, Articles 6 and 7 of the International Criminal Court Statute, the Nuremberg Code, The Geneva Convention, The United Nations Convention, The United Nations Declaration on the Rights of Indigenous Peoples, in your jurisdiction:

- 1) All Covid19/coronavirus19- vaccinations and experimentation (genetic bio-warfare) (Nationally).
- 2) All PCR Testing (Nationally).
- 3) All Masking (private and public spaces, all transportations by land, water, and sea- Nationally).
- 4) All Lockdowns (Nationally).
- 5) All Quarantines (Nationally).
- 6) All closures of Provincial and Regional) boundaries
- 7) All closures of International Borders.

This will serve as your **lawful notice** to cease and desist all actions described above, effective immediately.

Furthermore, we declare all of New Zealand, OPEN, upon publication of this order (including all Borders, and those between New Zealand and Australia.

**Please Take Note** that this Notice is served on you both in your professional capacity and in the private (refer attached notes for implications)

#### Notes to accompany the Notice to NZ Police Officers

- a. We The People of NZ are tired of the corruption of fine men and women in blue by their overlords and now make this assertive stand; in order to jolt you into educating yourself in the fraud and criminality you are being made complicit in. It is our hope that we shall never need to act on this Order against you in the Private. But rest assured we shall if you do not Cease and Desist. As lives are now being lost daily due to the criminal actions of your colleagues in supporting the Govt imposed criminality surrounding "Covid19"
- b. This Notice is addressed to you in both your professional capacity (your job) and your private capacity. Your Employer or Police Association or Insurer may indemnify you for the former; but not the latter. Neither will any of those parties serve any prison term (or worse) imposed on you by a People's Tribunal or alternative jurisdiction considering any Crimes Against Humanity for which you may be found guilty.
- c. Any actions on your part in supporting any of the Government's unlawful edicts/Orders/Regulations/Mandates in respect to "Covid19" (a so-called virus for which no evidence exists anywhere in the world; and certainly not in NZ) constitute Crimes Against Humanity under multiple international and local codes including the Nuremberg Code.
- d. Like the German officers of the Third Reich; a defence of "I was only following orders/doing my job" will likely not save you; or the consequences of your actions on your career; you life and the wellbeing of your family. We urge you to consider your actions carefully; and determine on which side of history you wish to be remembered.
- e. It is contended that the entire fraudulent "Covid19" "epidemic" is an unproven experiment on the global population; which the NZ Govt is gleefully participating in. The actions of this government and NZ Police as its Enforcement Agency fall under the gambit of the Nuremberg Code 1947 (copy attached) as Crimes Against Humanity.
- f. Forced Lockdowns; Mask Mandates; Business Closures; Social Distancing Mandates – these are all having significant harm on the people of NZ. In direct contravention of your Oath to protect the tangata (people) of this whenua (land).
- g. We invite you to join your colleagues from different nations (eg Spain and Italy) who have joined We The People and the side of Lawful Behaviour – setting aside the "Legal" which is clearly unlawful.
- h. Please be aware that every communicate you make (email/phone/text) along with every action you take – is all being recorded. You cannot escape the eventual judging of your actions – or inactions. Each officer of the NZ Police force shall be judged in due course. Some already have been.
- i. Know this – though you be some 10,000+, We The People who are the true Patriots of NZ – amount to over 100,000 and are growing daily. As Tyranny draws closer to the front doors of our homes; the tide of opinion is turning; and more people are becoming increasingly hostile towards you and your colleagues. We shall no longer stand by and endure your criminal actions.
- j. You have a sworn duty to uphold and maintain the peace. Yet many of your colleagues are currently breaching the peace; escalating situations and committing crimes to prevent "infringements" – for example assaulting and/or "arresting" those who breach a Regulation or order; rather than merely issuing an Infringement Notice. You know this is wrong. As do we.
- k. Failure to comply with this Cease and Desist Order will bring misery and shame to you and your family. Please take serious stock of these warnings.

## The Nuremberg Code (1947)

### Permissible Medical Experiments

The great weight of the evidence before us to effect that certain types of medical experiments on human beings, when kept within reasonably well-defined bounds, conform to the ethics of the medical profession generally. The protagonists of the practice of human experimentation justify their views on the basis that such experiments yield results for the good of society that are unprocurable by other methods or means of study. All agree, however, that certain basic principles must be observed in order to satisfy moral, ethical and legal concepts:<sup>1</sup> The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment. The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs, or engages in the experiment. It is

1. a personal duty and responsibility which may not be delegated to another with impunity.
2. The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.
3. The experiment should be so designed and based on the results of animal experimentation and knowledge of the natural history of the disease or other problem under study that the anticipated results justify the performance of the experiment.
4. The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.
5. No experiment should be conducted where there is an a priori reason to believe that death or disabling injury will occur; except, perhaps, in those experiments where the experimental physicians also serve as subjects.
6. The degree of risk to be taken should never exceed that determined by the humanitarian importance of the problem to be solved by the experiment.
7. Proper preparations should be made and adequate facilities provided to protect the experimental subject against even remote possibilities of injury, disability or death.
8. The experiment should be conducted only by scientifically qualified persons. The highest degree of skill and care should be required through all stages of the experiment of those who conduct or engage in the experiment.
9. During the course of the experiment the human subject should be at liberty to bring the experiment to an end if he has reached the physical or mental state where continuation of the experiment seems to him to be impossible.
10. During the course of the experiment the scientist in charge must be prepared to terminate the experiment at any stage, if he has probable cause to believe, in the exercise of the good faith, superior skill and careful judgment required of him, that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.

## How to use these documents

1. There is no need to autograph (sign) the document; as you are serving this as a representative of the Living Men and Women of NZ. We recommend you do not. The Officer served will possibly know who you are – from your car rego or similar.
2. The above pages should be copied and stapled together; so you are presenting one document with three sheets. Page 2 & 3 could be double sided to save paper.
3. We strongly recommend you gain some understanding of your Rights when dealing with AGENTS of THE CROWN; in particular Police Officers. A good video may be found on Telegram under **SilentNoLonger** (public channel) posted 18Aug2021 or on the **NelsonKnight** channel on Rumble “How to handle yourself with police enforcers”
4. Do not allow yourself to be drawn into contract – do not supply your name other than politely giving your first name. Start the convo by asking questions; that sets you in control. Remember – they are civil servants; you pay their wages!
5. Be polite and friendly
6. Ask the Officer: “Is it correct NZ operates a voluntary by consent Police system?” They must answer yes. If not – show them the extract from the NZ Police website that states that exactly. Then you may say: “thank you – I do not contract. I do not consent”; then walk away with a smile.
7. Before you do – get their name or badge number. Write it on the Notice.
8. Record the interchange and the document you are about to serve.
9. Hand the Notice and use the words: “Officer (name or number) you are hereby served this Cease and Desist Order – in the public and the private. You are Ordered to cease all actions on the Notice with immediate effect; or face the consequences of not so doing”
10. Save your recording. Log the serving of the C & D on the Telegram Page
11. Repeat this process with as many different Police Officers as possible. When a specific cop has received 20-30 of these; he/she may start realising people are upset. And we are many. And they better wake their ideas up and think about this some more.
12. More assertive action is planned. These C & D Notices are largely educational in purpose. However – they shall be used as Evidence in future planned criminal proceedings against Officers who choose not to cease and desist.
13. Share your stories with friends; along with these documents. When we all start realising that the Policy Enforcers need to get back to their proper job of Keeping The Peace and that We The People have the power to force them to do that; then NZ will change for the better. The power is now literally in your hands!
